RELEASE FROM LIABILITY

Releasor, being of lawful age, (or, in the case of a minor, through his/her parent or guardian) in consideration of being permitted to participate in various shooting disciplines and activities at the Sparta Hunting and Fishing Club, either as a member or guest, do for myself, my spouse, legal representatives, heirs, assigns and subrogors, hereby release, waive, and forever discharge Releasees from any and all liability for and all losses and damages of any type or kind, and from and from any and all claims, suits, demands, actions or rights of actions, of whatever kind either in law or equity, arising from or by reason of death, personal injury known or unknown, or property damage resulting from any incident which may occur during Releasor’s presence at the Sparta Hunting and Fishing Club, and/or participation in any activity, whether caused in whole or in part by the Releasees or any other person or thing at the Sparta Hunting and Fishing Club while Releasor is present. Releasor, and his/her parent or guardian in the event Releasor is a minor, agree to fully indemnify, defend and hold Releasees harmless for all Releasor’s actions or omissions while at Sparta Hunting and Fishing Club. There is no limit to this liability.

Releasor assumes full responsibility for the risk of bodily injury, death or property damage due to negligence of the Releasees of any other third party or thing while at the Sparta Hunting and Fishing Club, and while competing, officiating, working, spectating, or for any purpose at the Club.

Releasor fully and completely releases the Releasees and any of its related parties of and from all liability to Releasor and to anyone or any entity claiming by, through or under Releasor, by subrogation or otherwise, it being Releasor’s intent to fully waive and release subrogation rights.
